CONNECTING THE GAS CYLINDER

SAFETY NOTICE



RISK OF FIRE AND EXPLOSION

- The appliance can only be operated with a pressure regulator. Also read and observe the assembly instructions and instructions for use, which are separately enclosed with the pressure regulator.
- The gas hose may have to be replaced if respective national regulations or the lifetime of the hose line require this.
- Gas hose and pressure regulator must be replaced at regular intervals. (For this, please refer to chapter Cleaning/Servicing.)
- Get information at a specialist shop when purchasing or renting gas cylinders.

- Make sure that there are no sources of ignition, open fire or the like in the vicinity, when connecting or replacing the gas cylinder.
- Make sure that the gas hose does not have a kink in it or is chafed and that its entire length is accessible.
- After installing the gas cylinder, please check all connection points for leak tightness using a commercially available leak detection spray or soapy water. If there are no leaks, clean the connections with water after the inspection.
- Checking for leaks with an open flame is strictly prohibited!
- The appliance operates on a properly filled 9Kg gas cylinder.

ASSEMBLY PROCESS



1. Place the gas cylinder into the patio heater.

2. CONNECTING THE GAS CYLINDER:

Attach the regulator hose to the regulator and then turn the connector (right-hand thread) of the pressure regulator onto the thread on the gas cylinder as shown on the diagram on page 13 of this instruction manual.

3. Spray all sealing points with standard leak detection spray or brush on soapy water (ratio 1 part soap/3 parts water). Open the valve on the gas cylinder. Bubbles will form wherever there are leaks. Close the valve on the gas cylinder and fix the leak. Then repeat this step until all leaks are fixed.

CHANGING GAS CONNECTION



Remove the two screws at the top of the burner head.





Loosen the swivel nut on the gas hose by turning it clockwise and then replace the gas hose with a new one. Connect the swivel nut to the thread of the gas tap by turning it anticlockwise and then tighten it with a suitable wrench. After checking for leaks, reattach the clip.





INSTALLATION

SAFE APPLIANCE LOCATIONS

This appliance shall only be used in an above ground open-air situation with natural ventilation, without stagnant areas, where gas leakage and products of combustion are rapidly dispersed by wind and natural convection.

Any enclosure in which the appliance is used shall comply with the following:

An enclosure with walls on all sides, but at least one permanent opening at ground level and no overhead cover (see Example 1). Within a partial enclosure that includes an overhead cover and no more than two walls (see Example 2 & 3).

Within a partial enclosure that includes an overhead cover and more than two walls, the following will apply:

At least 25% of the total wall area is completely open, and at least 30% of the remaining wall area is open and unrestricted.

In the case of balconies, at least 20% of the total wall area shall be and remain open and unrestricted (see Example 4 & 5).

SAFETY NOTES



CAUTION

PLEASE READ CAREFULLY THE FOLLOWING SAFETY GUIDELINES **BEFORE OPERATION.**

- This patio heater is not for commercial use.
- Do not use the patio heater for indoors, as it may cause personal injury or property damage.
- Do not place articles on or against this appliance.
- Do not use or store flammable materials near this appliance.
- Do not spray aerosols in the vicinity of this appliance while it is in operation.
- This outdoor heater is not intended to be installed on recreational vehicles and/or boats.
- Repair should be done by a qualified service person.
- Improper installation, adjustment, alteration can cause personal injury or property damage. Do not modify this appliance.
- Never replace or substitute the regulator with any regulator other than the factory-suggested replacement.
- Do not store or use gasoline or other flammable vapors or liquids in the heater unit.
- The whole gas system, hose, regulator, pilot or burner should be inspected for leaks or damage before use, and at least annually by a qualified service person.
- All leak tests should be done with a soap solution. Never use an open flame to check for leaks.
- Do not use the heater until all connections have been leak tested.
- Turn off the gas valve immediately if smell of gas is detected.
- Do not transport heater while it's operating.
- Do not move the heater after it has been turned off until the temperature has cooled down.
- Keep the ventilation opening of the cylinder enclosure free and clear of debris.
- Do not paint the radiant screen, control panel or top canopy reflector.
- Control compartment, burner and circulation air passageways of the heater must be kept clean. More frequent cleaning may be required as necessary.

- The gas cylinder should be turned off when the heater is not in use.
- Check the heater immediately if any of the following occurs:
 - the heater does not reach temperature.
 - the burner makes popping noise during use (a slight noise is normal when the burner is extinguished).
 - smell of gas in conjunction with extreme yellow tipping of the burner flames.
- The regulator/hose assembly must be located out of pathways where people may trip over it or in area where the hose will not be subject to accidental damage.
- Any guard or other protective device removed for servicing the heater must be replaced before operating the heater.
- Adults and children should stay away from high temperature surface to avoid burns or clothing ignition.
- Children should be carefully supervised when they are in the area of the heater.
- Clothing or other flammable materials should not be hung on the heater or placed on or near the heater.
- Do not install or use this appliance indoors.
- If there is any evidence of excessive abrasion or wear, or if the hose assembly is damaged do not operate the appliance until a replacement hose assembly has been obtained from your authorized service provider Ensure that the replacement hose assembly is as specified by the manufacturer.
- Due to radiant heat Certain materials or items may be seriously damaged if stored under or near this appliance while it is in operation.
- Remove any packaging/transit protection prior to operating this appliance.
- The guard is fitted to this appliance to reduce the risk of fire or injury from burns and no part of it should be permanently removed.
- For protection of young children or the infirm, a secondary guard is required.
- Inspect the hose assembly before each use of the appliance.
- Installation please refer to AS/NZS 5601 and the local authority for gas or electricity, etc.

TURNING ON



CAUTION: A small amount of deflagration may occur on the burner when igniting and when switching off the device. This does not constitute a fault with the device and is no cause for alarm. Always

keep a sufficient distance from the burner.

- **1.** Turn on the gas cylinder.
- 2. Press and turn the control knob to the "A" and at the same time continuously press the piezo-ignition button.
- **3.** After successful ignition, keep the control knob pressed for another 20 seconds. This brings the burner up to the necessary operating temperature and active the thermocouple.
- 4. You can turn the control knob between " \triangle " and " \triangle " to adjust flame.
- 5. The rare case that the heater does not ignite after the piezo-ignition button has been pressed 4 or 5 times, repeat the procedure after 2 minutes.

TURNING OFF

1. To switch off the device, close the valve on gas cylinder.



NOTE: The device can also be ignited by other means of ignition (candle lighter, long match). Wear gloves and keep a safe distance from the burner! Caution, accessible parts can be extremely hot. Keep away from children.

MALFUNCTION AND REMEDY

PROBLEM: The patio heater does not ignite.

SOLUTION: The patio heater contains a tilt prevention device, making possible to encapsulate the gas feed can in a globe during transportation. In order to activate the gas feed, shake the burner head lightly to propel the globe back to its original position and ensure a proper supply of gas.

PROBLEM: There is a gas smell.

SOLUTION: Do not use the device if there is a gas leak. The gas supply must be shut off if this occurs during use. Check the device and replace damaged parts before using it again.



FIRST AID MEASURES



FIREFIGHTING MEASURES

- Bring bystanders to safety! If possible, close the valve on the gas cylinder. Cool off the gas cylinder with water. When doing so, pay attention to your own safety! A repeated spontaneous, explosive combustion is possible.
- In case of fire, filled compressed-gas cylinders should be removed from the flammable surroundings. If this is not possible, the compressed-gas cylinders should be protected against too intensive heat by spraying them with water or similar suitable means from a protected location.

MEASURES AFTER INHALING GAS

- High concentrations can cause suffocation. Symptoms can be the loss of the ability to move and consciousness. The victim is not aware of being suffocated. In low concentrations dizziness, headaches, nausea and problems with coordination can arise.
- Bring the victim to a location where he/she can breath fresh air. Call a physician or the emergency services. Conduct first aid measures in the event of respiratory arrest.

MEASURES AFTER SEVERE BURNING OR SCALDING

- There is an acute risk of hypothermia and shock. Call emergency services immediately!
- Immediately extinguish possible burning clothing with water or put out the flames using a thick blanket.
- In the case of scalding: Immediately remove clothing.
- In the case of burns: Leave clothing on the body.
- Cool with cold water for at least 15 minutes until the pain subsides.
- Cover the respective area with a sterile Metalline compress. Place the side coated

with Metalline on the injured skin and loosely fixate with a gauze bandage and a cravat.

■ Do not use any "household remedies" such as ointments, powder, oils, disinfectants, etc.!

MEASURES AFTER MINOR BURNS OR SCALDING

- In the case of scalding: Immediately remove clothing.
- In the case of burns: Only remove clothing if it does not stick.
- Cool with cold water for at least 15 minutes until the pain subsides.
- Allow minor burns or scalding without blistering to heal with the help of fresh air; do not cover with a plaster or any other dressing.

CLEANING/SERVICING

SAFETY NOTICE



- Despite careful processing of all individual parts, individual components can have sharp edges. Therefore, please wear safety gloves, to avoid getting cut.
- Hot surface: Do not clean the patio heater until it has sufficiently cooled off.

RISK OF FIRE AND EXPLOSION

- Do not use any flammable cleaning agents.
- Handling the gas installation/patio heater: Repairs and servicing of the gas-conveying parts can only be conducted by specialists authorized to do so.

- Do not make any modifications to the pressure regulator. The hose must be serviced after 5 years (refer to the date of manufacturer on the hose).
- Replace the pressure regulator and the hose after 10 years at the latest; even if no external damage can be detected. Make sure that the pressure regulator is approved for your country and the gas used and that it is adjusted to the correct output pressure (refer to Technical Specifications). A new hose cannot be longer than 1.5 m.
- All components, which were sealed by the manufacturer or its representative, cannot be manipulated or modified.
- Together with oil, the gas forms an explosive mixture. Never try to loosen tight valves or regulator knobs with oil or penetrating oil.
- The hose assembly is to be replaced prior to the appliance being used if there is evidence of damage. (such as excessive abrasion or wear)
- Any replacement hose assembly is to be as specified by the manufacturer.



- Do not use any aggressive cleaning agents or those containing chlorine.
- Wipe the soiled surface with a damp cloth or rinse with hot water. If necessary, use a mild detergent. Rinse with water and wipe the entire surface with a microfiber cloth.
- When using a mild cleaning agent, the manufacturer's instructions / product information should be observed in order to avoid surface damage.
- Allow the device to dry completely before using it again.

STORAGE/TRANSPORT

SAFETY NOTICE



RISK OF FIRE AND EXPLOSION

- Store the gas cylinder out of the reach of children.
- Keep the gas cylinder away from flammable gases and other oxidizing substances.
- Escaping liquefied gas is heavier than air and sinks to the ground. Do not store the gas cylinder in the house, under ground level (e.g. basements, wells, underground car parks, etc.) or in non-ventilated spaces, in which escaping gas could accumulate.
- Protect the gas cylinder against direct sunlight and other heat sources.
- Store the gas cylinder at temperatures under 40°C in a well ventilated space and where it is protected against the influences of weather.
- Store the gas cylinder in an upright position and ensure it cannot topple over.

- These storage instructions also apply to empty gas cylinders because these always contain a residual amount of liquefied gas.
- If possible, do not transport the gas cylinder in vehicles, in which the cargo bay/boot is not separated from the driver's cab. The driver must be aware of the possible risks of the load and he/she must know what to do in case of an accident or emergency.
- Transport the gas cylinder in an upright position and ensure it cannot topple over or slip/shift.
- Make sure the valve on the gas cylinder is closed and leakproof.
- Ask your gas retailer about effective national requirements and information.
- There is no limitation on the storage of appliances indoors provided that the cylinder is removed from the appliance.
- Storage of an appliance indoors with the cylinder attached is only permitted if the size of the cylinder complies with AS/NZS 1596: otherwise cylinders are required to bestored outdoors in a well-ventilated area.



Store the appliance in a dry room free of frost.
 Cover the appliance to prevent soiling and damages.

DISPOSAL





The product packaging is made of recyclable materials, which can be used for recycling. Dispose of this packaging correctly sorted in the collection bins provided.
