PRODUCT 12 MONTH WARRANTY AND LIMITATION OF LIABILITY




STEP 1

Place the base upright and have a second person support firmly to avoid injuries.

Insert the screw (d) with Spring ring (f), Gasket (k), Washer (e) and rubber washer (g) into the base from below. Please note the position of the washers. Place the large rubber washer (g) over the screw protruding at the top.



- Secure the screw from below using the socket key (j) and place the stand tube onto the screw from the top and slightly screw in.
- Note: the clamping plate is to protect the umbrella pole. When inserting umbrella poles with a diameter up to 38mm, please do not remove the clamping plate.
- When inserting 48mm umbrella poles, please remove adaptor and clamping plate.




Insert Lower Adaptor (i).
