

**Melbourne Trade Expo 2026 Volkswagen Amarok PanAmericana (“Promotion”)  
TERMS AND CONDITIONS**

1. Information on how to enter and prize details forms part of these Terms and Conditions. You accept these Terms and Conditions by entering the Promotion.
2. The promoter is **Bunnings Group Limited (ABN 26 008 672 179) of Level 2 East Tower, 570 Swan Street, Burnley VIC 3121**, telephone number 03 8831 9777 (“Promoter”).
3. The Promotion will commence at 10:30 (AEST) on 25/06/2026 and will close at 20:00 (AEST) on 25/06/2026 (“Promotional Period”).
4. Entry is only open to Australian residents who, during the Promotion Period:
  - a) are aged 18 years or over;
  - b) are registered, attend and check into the Melbourne Trade Expo on Thursday 25 June 2026 between 10:30 to 20:00 at Melbourne Showgrounds. Must register via <https://fcm.eventsair.com/bunnings-trade-expo-2026---melbourne/customer-registration/Site/Register>; and/or
  - c) either:
    - (i) are, or sign up to and become, the registered holder of an existing and valid Bunnings PowerPass commercial account (either Standard, Apprentice, Owner Builder, Cash, Credit or 30-day account) (“PowerPass Account”) in connection with your business (an “Eligible Business”); or
    - (ii) are employed by, or are an owner of the Eligible Business, and are, or become an authorised user of their account (in your own name) in accordance with the terms and conditions applicable to that PowerPass Account.
5. 6. Directors, management and the employees of Volkswagen Group Australia Pty Ltd ABN 14 093 117 876 (“Prize Supplier”) or the Promoter, retailers, suppliers, agencies, companies or premises associated with this Promotion and their immediate family members are ineligible to enter. Immediate family means any of the following: spouse, child, parent, brother, or sister.

**Entry**

7. To enter, you must, during the Promotional Period:
  - a) Attend Melbourne Trade Expo on Thursday 25 June 2026 between 10:30 to 20:00 at Melbourne Showgrounds.
  - b) Spend \$300 or more (including GST) in a single transaction (not including Bunnings gift cards) (“Qualifying Transaction”), at the Melbourne Trade Expo (“Qualifying Spend”). Every \$300 equates to one entry, max 50 entries.
  - c) Special Order transactions to the value of \$300 or more (including GST) are eligible to be Qualifying Transactions if paid for in full at the Melbourne Trade Expo and receipt is obtained from the Special Orders Desk at the Expo. Customers must register their Special Orders receipt to enter the competition by scanning the QR code at the competition stand located on the Volkswagen booth at the Melbourne Trade Expo.

- d) Any purchases made pursuant to the supply of goods on credit (for example, on a 30-day Credit Account) are excluded as a Qualifying Transaction.
- e) PowerPass members who register, attend and check into the event receive one entry into the Promotion that will be allocated to the account holder of the Eligible Business, including individuals who sign up to PowerPass on the day at the PowerPass desk in the PowerPass Lounge. If multiple PowerPass members register, attend and check into the event under the same Eligible Business, that Eligible Business will only receive one entry into the Promotion in accordance with this clause 7(e).
- f) All individuals including PowerPass and Non-PowerPass members who make a purchase must register for the competition by scanning the QR code at the competition stand located on the Volkswagen booth at the Melbourne Trade Expo, completing required details and uploading a copy of their receipt for proof of purchase. Follow the prompts to the registration page and input all requested details to register for the Promotion (including providing your full name, valid email address, mobile number and receipt upload, and agreeing to the Terms and Conditions by ticking the relevant tick box). All qualifying transactions made at the Melbourne Trade Expo will be accepted. Entries must be submitted by 11:59pm on Thursday 25 June 2026.

8. For clarity:

- a) the Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry;
- b) purchases of Bunnings gift cards and bonus redemption items do not count towards a Qualifying Transaction.

9. Individuals will receive one entry for every \$300 in a single Qualifying Transaction during the Promotional Period, up to a maximum for 50 entries. For example, you will receive:

- a) one entry for a Qualifying Spend of between \$300-\$599.99 in the one Qualifying Transaction;
- b) two entries for a Qualifying Spend of between \$600-\$899.99 in the one Qualifying Transaction;
- c) three entries for a Qualifying Spend of between \$900-\$1199.99 in the one Qualifying Transaction, and so on etc.

10. There must not be any overdue balance owing on your (or on your Eligible Business') PowerPass Account as at the date of winner determination on 15/07/2026 to be eligible to claim the prize. If you are drawn as the prize winner and there is an overdue balance owing on your (or on your Eligible Business') PowerPass Account, you (or your Eligible Business) must pay that overdue balance in full prior to becoming eligible to claim the prize. If the overdue balance is not paid within 14 days of being notified as the winner by the Promoter, you (or your Eligible Business) will forfeit any entitlement to the prize.

11. Any material failure by you or the Eligible Business to comply with the conditions imposed by the Prize Supplier(s) may result in the prize being cancelled or withdrawn without liability for the Promoter or the Prize Supplier(s).

12. Where relevant, the Promoter is not responsible for any dispute between you and the Eligible Business, or any person with whom you choose to, or choose not to, share the prize.

13. The Promoter reserves the right, at any time, to verify the validity of entries, and your role in connection with your Eligible Businesses (including your age and place of employment, and your (or the Eligible Business') PowerPass Account status) and reserves the right, in its reasonable discretion, to disqualify you and your Eligible Business if the Promoter has reason to believe you or the Eligible Business have breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or improper misconduct which jeopardises or is calculated to jeopardise the fair and proper conduct of the Promotion. Errors and omissions will be accepted at the Promoter's

discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

14. The Promoter may, at any time, require you to produce documentation to establish to the Promoter's reasonable satisfaction the validity of your entries and/or verify your identity (including documentation establishing your identity, age, place of residence and place of employment within the Eligible Business). Individuals must provide a copy of their receipt as proof of purchase and to validate entries.
15. You must not:
  - a) tamper with the entry process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the entry process);
  - b) engage in any conduct that may jeopardise the fair and proper conduct of the promotion;
  - c) act in a disruptive, annoying, threatening, abusive or harassing manner;
  - d) do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this promotion;
  - e) breach any applicable laws; or
  - f) behave in a way that is otherwise inappropriate.

#### **The Draw**

16. There will be 1 winner determined in respect of this promotion.
17. There will be 1 draw conducted. The draw will take place at 10am (AEST) on 15/07/2026 at Gadens Lawyers, L13 447 Collins Street, Melbourne, Victoria 3000 in the presence of an independent scrutineer.
18. The Promoter may draw additional reserve entries and record them in order in case the winning entry/entrant is deemed invalid or the prize is unclaimed ("**Reserve Entrant**"). The registered individual will be notified in writing and by telephone within two (2) business days of the draw, and the first name initial, last name, post code and name of the winner will be published online at <https://trade.bunnings.com.au/campaign/trade-expo/melbourne> from 22/07/2026, for a period of 28 days.

#### **The Winner**

19. The prize will be awarded to the winning eligible individual to which the first validly drawn entry from the entries received during the Promotional Period relates (**Winner**).
20. a) The Winner will be eligible to claim the Prize, provided the Winner:
  - i. is an adult aged 18 or over;
  - ii. can lawfully accept the prize;
  - iii. has a valid Australian driver's licence;
  - iv. has been provided with a copy of (and agrees to comply with) these Terms and Conditions; and

v. consents to be nominated.

b) Once the Winner has been confirmed as approved by the Promoter, they will be the winner for the purposes of these Terms and Conditions, and they will be deemed to accept these Terms and Conditions.

## The Prize

21. The first valid entry drawn from the entries received during the Promotional Period will win a 2026 Amarok PanAmericana 3.0 TDI 600 4MOTION 10 Speed Auto Reed Green Metallic vehicle. The prize value is approximately \$81,123 (including GST), based on the MY25 Manufacturer's Recommended Driveaway Price. Final vehicle specifications and value may vary depending on MY26 pricing and availability at the time of delivery. The prize comes with a five-year standard 5-Year warranty and on-road costs, including stamp duty, registration, 12 months compulsory 3rd party ("CTP") insurance, and dealer delivery. Should the above vehicle be unavailable, the Prize Supplier will choose another model of equal or higher value from its current inventory, at the Prize Suppliers discretion.
22. The Prize must be picked up from Bayford Camberwell Volkswagen, 675 Burwood Road, Hawthorn East, Victoria 3123 ("Camberwell Volkswagen"). The winner is responsible for all costs associated with the prize not expressly included, such as petrol, comprehensive insurance, damage, or any other costs or liabilities arising from the date of delivery. The winner is responsible for any expenses incurred in travelling to and from Camberwell Volkswagen. If the winner resides outside Victoria or requests delivery, all delivery or transport costs are the responsibility of the winner.
23. If the Winner is, through any legal incapacity or otherwise, unable to register the vehicle in their own name, then the Winner may assign the car to another person (who consents to such assignment) with legal capacity for the purpose of registration. The Promoter and Prize Supplier take no responsibility for any such arrangements between the Winner and their assignee. The Winner must provide the Promoter with certified copies of all required documentation as and when required by the Promoter. It is a condition of accepting the prize that the Winner (or their representative) may be required to sign a legal release in a form to be determined by the Promoter in its discretion.
24. If any dispute arises between you and the Promoter concerning the conduct of this promotion or claiming a prize, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. In all other respects, the Promoter's decision in connection with all aspects of this competition is final.
25. The total prize pool value is up to \$81,123 including GST. The prize is not transferable or exchangeable and cannot be taken as cash. Without limiting any other term of these Terms and Conditions, the prize (and elements of the prize) must be taken as and when specified or will be forfeited with no replacement. If you forfeit the prize or any element of the prize for whatever reason, you will not be given cash or any alternative prize as a substitute. The prize is subject to any additional terms and conditions imposed by the Prize Supplier or the Promoter. The prize value is an estimate only, based on MY25 model pricing available at the time of preparing these Terms and Conditions. The prize supplied will be a MY26 vehicle, for which final pricing has not yet been confirmed, and the actual value of the prize may differ from the estimated value stated above. The Promoter is not responsible for any change in prize value. You agree that if a prize (or element of a prize) is unavailable for any reason, the Promoter may provide another item of equal or higher value, subject to any necessary approval by the state/territory gaming authorities.
26. The Promoter is not liable for entries, prize claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted for reasons outside the Promoter's reasonable control.
27. If the prize has not been accepted or claimed by 9am AEST on 05/08/2026, or if, after making all reasonable attempts, the Promoter cannot contact the Winner (or the Winner does not contact the Promoter), the relevant entry will be discarded and the Promoter will either re-award the prize to a Reserve Entrant/s and/or carry out an unclaimed prize draw at 10am AEST on 05/08/2026 at the same place as the original draw, to distribute the prize to the next drawn valid entrant. Any winner from this

process will be notified in writing and by telephone within two (2) business days of the unclaimed prize draw and the name of the winning Eligible Business (where applicable) and first name initial, last name, post code of the winner will be published online at <https://trade.bunnings.com.au/campaign/trade-expo/melbourne> from 12/08/2026. The vehicle is to be collected by the winner from “Camberwell Volkswagen”, which will be available within thirty (30) days of the unclaimed prize draw date.

28. If the prize remains unclaimed at the end of this Promotion, or if the prize winner cannot be found, that information will be published on the Website on 02/09/2026.
29. As a condition of accepting the prize, the Winner consents to the Promoter and the Prize Supplier using their Eligible Business' details (where applicable) and their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter and the Prize Supplier.

### General

30. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, (for example, due to software, hardware or communications issues, government directives, public health orders, technical difficulties, unauthorised intervention, tampering or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
  - (a) to disqualify any affected entrants and any entry/entries made on their behalf or by any of their owners and employees; or
  - (b) subject to any necessary approval by the state/territory regulatory authority, extend, suspend, terminate or cancel the Promotion, as appropriate.
31. Any cost associated with accessing the promotional website is your responsibility and may be dependent on the Internet service provider used. The Promoter is not liable for any problems with communications networks outside its reasonable control. The use of any automated entry software or any other mechanical or electronic means that allows you to automatically enter repeatedly is prohibited and will render all entries related to you or your Eligible Business invalid.
32. The Promoter is not responsible for any tax implications arising from you winning the prize. You and your Eligible Business should seek independent financial and taxation advice. If for GST purposes this promotion results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
33. You may have consumer rights under statute including under the *Competition and Consumer Act 2010* (Cth), which may be relevant to any issue or problem you encounter in relation to this promotion and cannot be excluded or restricted. Nothing in these Terms and Conditions excludes or restricts those rights. See [www.accc.gov.au](http://www.accc.gov.au) for more information about those rights.
34. Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
35. Without limiting the previous paragraphs, the Promoter and the agencies and companies associated with this promotion are not liable for any loss of, damage to or delay in delivery of the prize, or for any damage that occurs due to circumstances beyond the Promoter's reasonable control. Unless otherwise specified, the prize will only be delivered to addresses in Australia.

36. As a condition of accepting the prize, the prize taker must sign any legal documentation as, and in the form, required by the Promoter and/or the Prize Supplier in their reasonable discretion, including but not limited to a legal release and indemnity form.

## Privacy

37. The Promoter endeavours to comply with the Australian Privacy Principles contained in the *Privacy Act 1988* (Cth). To request access to, or to update or correct, personal information the Promoter holds about you, you can contact the office of the Promoter at the address set out in clause 2 or view the Privacy Policy for instructions. The Privacy Policy also contains information about how you can complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, Prize Supplier and, as required, to Australian regulatory authorities. This may include disclosures to organisations outside Australia including in places such as USA, Singapore, EU countries, New Zealand, Japan, Vietnam, India and United Kingdom. Entry is conditional on providing this information. The Promoter may also, if the opt-in box is ticked at the time of Registration, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning you in connection with this Promotion. If you have marked the "opt-in" box during the Registration process, you consent to the Promoter keeping your personal information on its database to use for future marketing purposes, including contacting you by electronic messaging provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). By entering, you consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this promotion.
39. By accepting the prize, the Winner must acknowledge and agree that:
- (a) the Promoter may provide their Personal Information (as defined in the *Privacy Act 1988* (Cth)) (e.g. first name, last name, address, suburb, state, postcode, phone number, email address, gender, date of birth) to the Prize Supplier in order for the Prize Supplier to provide the prize; and
