Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Exposure limits have not been established by SWA for any of the significant ingredients in this product.

The ADI for Ethylene glycol, propylene glycol polymer is set at 0.02mg/kg/day. The corresponding NOEL is set at 40mg/kg/day. ADI means Acceptable Daily Intake; NOEL means No-observable-effect-level. Data from Australian ADI List, June 2014.

No special equipment is usually needed when occasionally handling small quantities.
