- 3.2 In order to qualify for a Redemption Reward, the Redemption Eligibility criteria must be met.

4 OFFER

- 4.1 The Offer and Redemption Rewards are as outlined above.
- 4.2 In order to facilitate this offer, we will charge customers \$0.1 per bonus battery pack with the purchase of Qualifying Purchase. However, in the same transaction the Qualifying Purchase will be reduced in price to the value charged for the bonus battery pack. (Example: Customer selects an AEG 5-piece kit with a retail value of \$999 and requests to claim the instant bonus battery.
