Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. As a water based product, if spilt on electrical equipment the product will cause short-circuits.

Small spill: Mop up and wash residue to drain with copious amounts of water. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers for disposal.

Large spill: Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Precautions for Safe Handling
