1. **Weekly Winner Selection (individual)**

- a) Five (5) eligible Nominated Volunteer Coach nominees will be selected each week during the Promotion Period ("**Weekly Coach Selection**") resulting in a total of 125 Nominated Volunteer Coach weekly winners over the duration of the Promotion Period.
