- 2.2 Acting reasonably, we may exclude any person from entering into the Promotion.

3 ENTRY

- 3.1 "Qualifying Purchases" must be made during the "Promotion Period" as outlined above. We do not accept responsibility for any requests which are lost, misplaced, or not received in time (whether due to a delay in delivery, technical issue or otherwise).
- 3.2 In order to qualify for a Redemption Reward, the Redemption Eligibility criteria must be met.

4 OFFER

- 4.1 The Offer and Redemption Rewards are as outlined above.
- 4.2 In order to facilitate this offer, we will charge customers \$0.1 per bonus battery pack with the purchase of Qualifying Purchase. However, in the same transaction the Qualifying Purchase will be reduced in price to the value charged for the bonus battery pack. (Example: Customer selects an AEG kit with a retail value of \$599 and requests to claim the instant bonus battery. The customer will be charged \$.01. in total for the bonus battery but the AEG kit will be reduced from \$599 to \$598.99. In total, the customer will pay \$599 to finalise the purchase).
- 4.3 You are responsible for any tax or other costs arising in relation to, or associated with, this Promotion.
- 4.4 If we provide you with a refund for products (purchased in relation to this Promotion as part of a Qualifying Purchase) for a change of mind in accordance with our Returns Policy (available on our website), we reserve the right to request the return of the Redemption Reward. Notwithstanding in other terms or policy, your ability to obtain a full refund may be conditional upon you also returning the Redemption Reward at the same time.

- 6.1 We will not be liable for any loss, damage or injury (including but not limited to any indirect or consequential loss) suffered or incurred by you (or any other person) as a result of or in connection with the promotion or your use or consumption of a Redemption Reward, except for any liability under the Australian Consumer Law or other liability which cannot be excluded by law.
- 6.2 We may, acting reasonably, replace or amend these Terms or modify, suspend, extend, terminate or cancel the Promotion at any time.

7 DEFINED TERMS AND INTERPRETATION

- 7.1 In these Terms, the following words have the following special meanings:
 - "**Terms**" means these promotion terms and conditions (as amended from time to time);
 - "**we**", "**our**", "**us**" means the Promoter of the promotion specified above (or, if not specified, Bunnings Group Limited); and
 - "**you**" means a person entering the Promotion.
