



## Instant Battery Bonus – Terms & Conditions

1. This offer is for three days only (**Friday 29<sup>th</sup> of November to Sunday 1<sup>st</sup> of December**) and is only available on **purchases in store at Bunnings** (subject to stock availability).
2. Marketplace purchases, Tool Kit Depot purchases and purchases online are excluded.
3. If a customer purchases 18V Qualifying Combo Kit/s or 18 V Qualifying Skin/s from one of the four selected brands (or a combination of)(**Qualifying Products Offer**) in the one transaction meeting the below spend thresholds, they will qualify for an instant bonus of a 5AH 18V battery from one of the 4 selected brands (details below). The offer consists of three spend thresholds. Depending on the amount spent on the Qualifying Products Offer customers will qualify for one, two or a maximum of three 5Ah 18V batteries from one of the 4 selected brands.

<b>GET 1 x 18V BATTERY</b>	<b>When you spend \$599 or more</b>
<b>GET 2 x 18V BATTERIES</b>	<b>When you spend \$1099 or more</b>
<b>GET 3 x 18V BATTERIES</b>	<b>When you spend \$1499 or more</b>

4. **The above amounts are inclusive of GST.**
5. The four selected brands are all trade brands: **Makita, DeWalt, AEG & Bosch Professional.**
6. The Qualifying Products Offer are 18V Power Tool or Power Garden products from one of the four selected trade brand. **The Qualifying Products Offer** can consist of 18V Qualifying Combo Kit or 18V Qualifying Skins (or a combination thereof) and must meet the spend thresholds . Purchases of individual batteries and chargers will not qualify for bonus batteries.
7. The above spend thresholds must be based on a single Qualifying transaction value, not a cumulative purchase of multiple qualifying items. (Example: Three Makita kits purchased at \$200 using separate transactions would not qualify for one Bonus Makita 5Ah battery)
8. In order to facilitate this offer, Bunnings team member will charge you \$0.1 per bonus select brand 18V 5AH battery with the purchase of Qualifying Products Offer. However, in the same transaction a 18V Qualifying Combo Kit or 18V Qualifying Kit must be reduced in price to the value charged for the Bonus batteries.(Example: Customer selects an AEG 10-piece kit with a retail value of \$1,999 and requests to claim the instant bonus of three select brand 5AH AEG 18V batteries. The customer will be charged \$.03. in total for the three 5AH 18V select brand batteries but the AEG 10-Piece kit will be reduced from \$1999 to \$1998.97. In total, the customer will pay \$1,999 to finalise the purchase).



9. The 18V Qualifying Combo Kit/s or 18V Qualifying Skin/s (or a combination of) purchased as part of the Qualifying Products Offer and the bonus select brand 18V 5AH batter/ies must be purchased together as one transaction.
10. Where discount applies it will impact the transaction value. For example, for PowerPass customers and Bunnings team members that receive discounts.
11. Where products are marked down or are eligible for the application of Bunnings' price guarantee, the marked down price will be applied for the offer and will impact the transaction value.
12. Therefore, a customers' total spend amount per transaction must still meet the total spend thresholds above despite any discounts, vouchers or mark downs received.
13. Bunnings reserves the right at any time, solely at its discretion, to offer the customer a substitute qualifying combo kit skin or battery of equivalent value if a 18V Qualifying Combo Kit or 18V Qualifying Skin of a selected brand or 18V 5AH of selected brand is not available.
14. This offer is not transferable, cannot be re-sold and cannot be taken as cash.
15. This offer is not valid with any other Bunnings redemption offer.
16. Subject to the statutory consumer guarantees as provided under the Competition and Consumer Act, if a customer returns for 'change of mind' reasons a Qualifying 18V Combo Kit or 18V Qualifying Skin which it purchased as part of this offer, the select brand 18V 5AH battery/ies must also be returned.
17. If this offer is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of Bunnings, Bunnings reserves the right (acting reasonably) to modify, suspend, terminate or cancel the offer, as appropriate in the circumstances.
18. Nothing in these Terms and Conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties that are incapable of being excluded (Non-Excludable Guarantees). Except for any liability that cannot be excluded, including the Non-Excludable Guarantees, Bunnings (including respective officers, employees and agents) excludes all liability (including negligence) for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special, or consequential, arising in any way out of this offer.

## **Instant Battery Bonus – FAQs**

- **Is this offer available on Ryobi, Ozito or XU1 kits?**

No, the offer is only available on the four select Trade brands listed in the Terms and Conditions.

- **How long is the offer running?**

The offer will only be available on Friday the 29th of November 2024 until end of trading Sunday the 1st of December; it is a three day only offer (subject to stock availability).

- **Does the customer still get a PowerPass discount on the qualifying kit or skins purchased as part of this offer?**

Yes, customers are still eligible for a Powerpass discount when they purchase a qualifying kit and/or skin (combination thereof) if they are a PowerPass member. However, where discount applies it will impact the transaction value.



- Can customers purchase a Qualifying Products Offer online to gain Bonus Batteries?

No, this is an in-store only offer.

Can customers purchase a Qualifying 18V Kit or Qualifying 18V Skin that is ranged via Customer Special Orders and still get Bonus batteries?

Yes, customers can purchase a Qualifying 18V Kit and/or Qualifying 18V Skin (or a combination of) if they meet the following criteria:

1. They are from one of the four selected trade brands.
2. The transaction must be paid in full and completed within the three day offer period.
3. The Qualifying 18V Kits and/or Qualifying 18V Skins (or combination of) purchased must be part of the same transaction and meet one of the above spend threshold.
4. The Kit or Skin is a Power Garden or Power Tool 18V product.

- Can customers purchase a qualifying kit or skin with a larger voltage than 18V?

No, this offer is only available on 18V Qualifying 18V Kits and/or Qualifying 18V Skins from one of the four Trade Brands.

- If a customer purchases a Qualifying 18V Kit and/or Qualifying 18V Skin and received bonus batteries are they still eligible to claim a supplier redemption offer on that kit if it has a redemption offer available?

Yes, the redemption offer is provided by the Power Tool Supplier directly to the customer and is separate to this offer that is being provided by Bunnings.

- If a customer purchases a Qualifying 18V Kit and/or Qualifying 18V Skin at Tool Kit Depot that is from one of the four selected brands, and meets the above spend thresholds, can they claim bonus batteries at Tool Kit Depot?

No, this offer is only available in Bunning Stores and is not available at Tool Kit Depot stores.

- If a customer purchases qualifying Qualifying Products Offer can they get a bonus 5Ah battery from one of the other four selected brands?

Yes, a customer can get a bonus battery from one of the other four selected brands as their choice providing the transaction meets all the qualifying criteria and subject to availability.

- What is the maximum number of bonus batteries a customer can receive per qualifying kit or skin purchased in one transaction?

The maximum number of bonus batteries **per** Qualifying Products Offer purchased in the one transaction is three.



- Does the Makita instant redemption offer on selected skins also qualify the customer for additional Bonus batteries on top of the Makita Bonus 5Ah battery and charger offer?

No, both offers cannot be taken up within the same transaction. A customer can choose which offer they would like to receive

- Can customers change the Bonus battery to another battery size such as a 4Ah battery or a 6Ah battery?

No, the offer is only available on 5Ah 18V batteries from the four selected brands unless an alternative battery is offered due to stock issues at the store's discretion.
