**1 ACCEPTANCE OF TERMS**

**2 ELIGIBILITY**

- 2.2 Acting reasonably, we may exclude any person from entering into the Promotion.

**4 OFFER**

- 5 to redeem the offer, an eligible claimant must, during the promotion period, bring a 18v battery into a bunnings store to trade-in in order to receive one (1) \$50 discount on the purchase of a qualifying product.
