

## “BUNNINGS TRADE SHOW – ADELAIDE FEEDBACK SURVEY PROMOTION”

### TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
