This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

### **Section 4 - First Aid Measures**

#### **General Information:**

**Skin Contact:** Gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gently brush particles from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

**Ingestion:** If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

#### **Section 5 - Fire Fighting Measures**

**Fire and Explosion Hazards**: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

#### **Section 6 - Accidental Release Measures**

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC and Nitrile. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable Dust Mask. Otherwise, not normally necessary. Stop leak if safe to do so and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Contaminated area may be neutralised by washing with weak or dilute acid. #### Section 10 - Stability and Reactivity

**Reactivity:** When wet or in solution, carbon dioxide may be produced, especially when in contact with acids. If carbon dioxide builds up to high pressures, it may cause the packaging to rupture.

**Conditions to Avoid:** This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry.

**Fire Decomposition:** Combustion forms carbon dioxide, and if incomplete, carbon monoxide and possibly smoke. Water is also formed. Sodium compounds. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death. **Polymerisation:** This product will not undergo polymerisation reactions.

# **Section 11 - Toxicological Information**

### **Potential Health Effects**

#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. It may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** Long term inhalation of high amounts of any nuisance dust may overload lung clearance mechanism. No data for health effects associated with long term inhalation.

#### Skin Contact:

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use.
